1. Don't think of productivity improvements as discrete events. Rather, think of them as part of an ongoing regimen much as you would good eating or living habits.
2. If you are not using habits which promote productivity, then chances are there is waste imbedded in your organization. Yes, I know, 65% of your budget is spent in the classroom. But there is probably waste in that, too.
3. Most waste is invisible. Actually, rework and defective or poorly executed services are not the "**big bars on the Pareto**" chart. The biggest forms of waste come from not knowing somebody else has a better approach. Suppose you had a process which was developed in-house for \$100,000 last year, and was executed

perfectly (per the standards) every time so that there were no defects. But what if another district developed the same process five years ago, and had refined it each year since? What if their process was recognized best in class, and cost a fraction of what yours did to operate? And if you had only asked, what if they would have given it to you at no cost? The point is, as long as you don't know the other process exists, you cannot recognize the waste.

Healthy people, like healthy organizations, have developed good habits. These include being aware of what's going on around you, setting achievable goals, and adopting the disciplines for achieving and sustaining excellence. That's what **Best Practices Florida** is about. Check it out, and share your success stories.

## 2010 Education Summit Presentation Overviews

Following are highlights from four (4) of the presenters during the one-day Education Summit (Click on the presenter's name to view the entire presentation):

### **[Charter Schools USA](#) - "Monitoring of Research-based Instructional Practices: CSUSA Site Visit."**

This presentation focused on how schools can effectively monitor the use of research-based instructional practices to ensure increases in student learning and achievement. An historical perspective was shared which highlighted the evolution and refinement of the site visit process to its current state. Benefits to teachers included:

- Achievement goals and action plans are developed and communicated with all staff members.
- Teachers are given clear expectations of what is expected that aligns to their performance evaluations.
- Enhancement of professional development based on the site visit team recommendation.

Benefits to the organization included:

- Continuous improvement focused on student achievement.
- Structured walk-through process to improve dialog between administrators and teachers.
- Uniformity across the organization.

The presentation concluded with quantified results.

### **[Florida Virtual School](#) - "Increasing Learning Gains and Reducing Costs through Virtual Learning."**

This presentation focused on the increasing importance of virtual learning in today's environment, and how FLVS is designing its approaches to coincide with the interests and meet the needs of its students. Results provided by Tax Watch suggest that FLVS is producing impressive results. Benefits for school districts included helping meet VIP requirements, expand curriculum offerings, fill gaps, provide a credit recovery tool, offer another way for students to accelerate, address class size, and provide summer school options.

### **[Polk](#) - "Interactive Data Evaluation Assessment Systems (IDEAS), from Data to Classroom Teacher."**

This presentation demonstrated the capabilities of IDEAS, an in-house developed data management system. IDEAS provides student achievement data at multiple levels by all demographics and grade. Data can be displayed to facilitate interpretation using Point Charts, Bar Charts, and other tools. Another helpful feature is the color-coding of red, yellow and green to help pinpoint success and trouble areas requiring interventions.

## [Volusia](#) - "STARTS: Skills, Tips, and Routines for Teacher Success."

This presentation focused on the district's recruitment and retention initiative. Challenges prior to developing STARTS included:

- Constant training and retraining,
- Cost of training,
- Inconsistency of program, and
- Inability to build teams or relationships.

Critical success factors were also discussed which included:

- Buy-in at the top,
- Interdepartmental collaboration, and
- School-based communication.

Results have been impressive, including significant increases in retention of first year and ESE teachers, major issues faced by most districts.
